

Rules and Regulations:

- To be run under British Dressage rules (latest rule book).
- The Judges decision is final.
- Objections must be handed to the secretary in writing within 15 minutes of the end of the class with a £10 deposit.
- Any competitor found to be competing in a class for which they are ineligible will be asked to withdraw with no refund.
- Abusive behaviour towards any of the officials will not be tolerated & the perpetrator will be asked to leave without a refund.
- Competitors must wear the correct dress, footwear and hard hat (although show jackets are not required). Hard hats should have a 3 point harness and chin straps must be fastened while mounted. Hats must conform to current safety standards. See our website for full details.
- All warm up must be done with consideration to other competitors.
- Horses & Ponies must be 4 years and over.
- No horse/pony may be ridden in the same class by different riders.
- No mucking out of trailers/horse boxes on site.
- No dogs admitted on site.
- No refund of entry fees will be made unless accompanied by a doctor's or vet's certificate.
- All horses must have a passport and up-to-date vaccinations.
- The VHPRC Committee/Woodfield Stables/Landowner or anyone acting on their behalf will not be held responsible for any loss/accident to persons, animals or property. Riders, owners & spectators enter at their own risk.
- Horses/ponies must not be left unattended tied to the side of lorries/trailers.
- No hand grazing allowed.
- VHPRC has a safeguarding policy which is available to view on our website.
- All children under the age of 16 to be accompanied by an appropriate adult.
- In the case of bad weather it is the responsibility of the competitor to check with the organiser if the event is going ahead.

Horse/Pony and Rider combination never to have been placed 1st to 3rd in any dressage test (with more than 10 entries) at prelim level or above.
- Class 3 Prelim Prelim 2 (2016)
- Class 4 Veteran Horse Prelim 18 (2002)
Open to horses and ponies who are 15 years or over.
- Class 5 Mature Rider Prelim 12 (2005)
Open to riders of 35 years and over.
- Class 6 Novice - Open Novice 30 (2006)

Classes 1, 2 and 3 may be split into Junior (under 16 on day of competition) and Senior sections if there are enough entries. Entries may be limited depending on number of entries received.

Pre-entries only please - no entry allowed on the day of the show and only completed signed entries will be accepted.

Show gear is not required but all tack and riding equipment must be dressage legal and riding hats must be up to the current standard. Gloves must be worn.
